- Coordinating monthly Outreach Meetings. The group worked on a Tax Season 2021
 Campaign, website refresh. This group also plays a key role in planning for Tax Day &
 NWTRCC conferences. Also helping with updates to our Spanish-language literature.
- Coordinated Radio Interview about Wally/Juanita Nelson in February 2021.
- Wrote Tax Season 2021 article for United for Peace & Justice newsletter.
- Working with ad-hoc committees to create new proposals for our statement of purpose and our logo for the May 2021 meeting.
- Kept the office stocked with current NWTRCC literature, having literature printed as needed.
- Posted on Facebook, Twitter, and Instagram when appropriate.

Fundraising

- Coordinate fundraising committee with monthly conference calls. Main focus on NWTRCC finances & grant opportunities. We have also been exploring granting circles with Lida's help. With Lindsey's help, we are exploring new grants to apply for and soliciting famous liberals using information provided from their political donations.
- Submitted Grant to Peace Development Foundation in December, but it was rejected. Submitted final reports for Barrett Foundation & Muste grants.
- Working with Fundraising Committee (esp. Jim Stockwell and Carlos Steward) to hold a second online Art Charity Auction for NWTRCC sometime in 2021.
- Worked with Fundraising Committee and Sam L. on the <u>Bequest Campaign</u>, which launched at the beginning of October 2020.
- Completed November fund appeal by Bernard Offen and mailed it out. Finishing fund appeal by Lindsey Britt for May 2021.
- Composed 2021 budget for Fundraising Committee & AdComm, which passed at the November CC meeting.
- With Fundraising Committee, creating a new webpage for people who want to ask their churches to donate to NWTRCC: www.nwtrcc.org/church
- Sent out affiliate dues forms shortly after the May/November appeals.

Technical Assistance

- Composed Counseling Notes for newsletter.
- Have taken several of calls/emails on passports, a wage garnishment, frivolous warning letters, new W-4 form, FASFA, retirement funds, social security & home buying. When appropriate, I also connect callers and emailers to local people and groups.
