COLLECTIVE REDIRECTION to Black, Brown, and Indigenous Resistance!



For tax day 2017 Ithaca War Tax Resisters redirected war taxes to the Ultimate Reentry Opportunity (pictured), which helps people who are transitioning from jail or prison into the community, and to SHARE farm, made up of members of the Cayuga Nation who were burned out of their villages around 1780 by the U.S. government and are now trying to return to their traditional lands. In addition, war tax resisters in Philadelphia, New York City, San Diego, Los Angeles, Asheville, Redway (Calif), and Phoenix jointly reported their tax redirection to organizations led by Black, Brown, and Indigenous people in their local communities. About \$20,000 was given away as a stand against white supremacy in the U.S. government as well as in organizing communities.

Joining our actions with other groups



On tax day 2017 Milwaukee War Tax Resistance, Casa Maria Catholic Worker, Peace Action-Wisconsin, and Welfare Warriors took their message of "Move the money from bullets to bread!" to the U.S. Army Reserve Base in Milwaukee. The group called for "No more training our young to fight and harming their neighbors and contributing to the violence, bloodshed and misery in the world."

Other groups organized with the big Tax March events on April 15, while the **Southern California Alternative Fund** redirected taxes at a joint event with **Veterans for Peace**. Which local groups can you plan a tax day action with?
