ALTERNATIVE FUNDS in the NWTRCC NETWORK

Alternative funds provide an opportunity to pool resisted money plus donations from supporters. Usually around tax day the funds announce loans and/or grants to community, social change, peace, and humanitarian organizations of all sorts. Pooling our tax resisted dollars offers greater impact for even smaller amounts of resistance. Some funds will reimburse participating resisters if the IRS seizes money from them. Contact the funds directly to inquire about their guidelines and policies.
