<u>Proposal 2: Re-Arrange Wording of Statement of Purpose Based on Feedback</u> from the Youth Advisory Council

Primary feedback from the Youth Advisory Council (three rounds was focus groups with non-WTR activists in their 20s) was to (1) make the first paragraph the last paragraph, (2) use stronger language, and (3) explain WTR, and (4) include info about 50% of discretionary spending for militarism

Current Statement:

The National War Tax Resistance Coordinating Committee (NWTRCC) is a coalition of groups from across the U.S., formed in 1982 to provide information and support to people involved in or considering some form of war tax resistance (WTR). Affiliate organizations and individual supporters are joined together in a common struggle for a more just and peaceful society.

We oppose militarism and war and refuse to complicitly participate in the tax system which supports such violence. NWTRCC sees poverty, racism, sexism, homophobia, economic exploitation, environmental destruction and militarization of law enforcement as integrally linked with the militarism which we abhor. Through the redirection of our tax dollars NWTRCC members contribute directly to the struggle for peace and justice for all. NWTRCC promotes war tax resistance within the context of a broad range of nonviolent strategies for social change, and is firmly embedded in the peace movement.

NWTRCC's goal is to maintain and build a national movement of conscientious objectors to military taxes by supporting, coordinating and publicizing the WTR actions of groups and individuals. These actions include: war tax resistance, protest, and refusal; the redirection of military taxes to meet human needs; support of the U.S. Peace Tax Fund Bill and adjustment of lifestyle to avoid tax liability.
